

WITNESSETH that said Grantor for and in consideration of the sum of \$40.00 dollars to him in hand paid by said Grantee, the receipt of which is hereby acknowledged, and for and in consideration of the agreements and covenants hereinafter contained, does hereby grant, to the said Grantee the Right of Way to lay, maintain, operate, relay and remove a pipe line 160 rods long, and located in accordance with plat of definite location on the back hereof, for the purpose of the transportation of Natural Gas, with right of ingress and egress to and from the same, on, over and through certain lands situated in the County of Oklahoma State of Oklahoma, described as follows, to-wit:

of Hurco, in the State aforesaid, hereinafter called "Grantor" (whether one or more), for and in consideration of the sum of Ten and no/100 Dollars (\$10.00) cash in hand paid by OHIO PETROLEUM CO., an Ohio corporation, hereinafter called "Grantee", the receipt of which is hereby acknowledged, has and does by these presents grant, sell, convey, deliver and warrant to the said Grantee, its successors and assigns, a right-of-way and easement to lay, maintain, operate, repair, replace, alter, remove and remove a pipe line for the transportation of petroleum, petroleum products, gas, water, and/or any other liquid or gaseous substance, together with necessary fixtures, equipment and appurtenances therefor, over, through, across and upon the following described lands situated

In the Township of \_\_\_\_\_, \_\_\_\_\_ County, in  
the State of Oklahoma, to-wit:

East half (E½) of Section 14, Township Fourteen North ("14N")

Range One West (R1W)

containing .327 acres, more or less; it being intended hereby to include for the purposes and consideration herein stated, all the land owned or claimed by Grantor adjacent or contiguous to the land particularly described above, whether in the same or different section or sections.

Together with right of ingress and egress to and from said right-of-way, under the right of way, such route as may be selected by the Grantee.

Grantor and Grantor's heirs and assigns reserve the right fully to use and enjoy said premises except as far as such use and enjoyment shall be inconsistent with the rights of the Grantee, its successors or assigns. The Grantee, its successors or assigns, shall burn any and all pipe lines installed hereunder so that the same will not interfere with the cultivation of the land. The Grantee, its successors or assigns, shall pay any damages to crops, buildings, down trees, leaves or timber arising from the exercise by the Grantor, its successors or assigns, of any of the rights herein granted, such damages, if not mutually agreed upon, shall be determined by three (3) disinterested persons, one (1) of whom shall be appointed by the Grantor, one (1) by the Grantee, and the third by the two (2) appointed by the parties, and the written award of any two (2) of such persons shall be final and conclusive.

Grantor further agrees that the Grantee, its successors or assigns, shall have the right from time to time to lay, maintain, operate, repair, replace and remove an additional pipe line, through and across said premises for the purpose of carrying such additional pipe line to be laid along such route as may be selected by the Grantee, but for such additional pipe line installed hereunder, Grantee, its successors or assigns, shall pay to Grantor, or Grantor's heirs or assigns, a like sum per linear rod of pipe as that upon which the above consideration was based. The additional line rights herein granted may be assigned or transferred in whole or in part, separate and apart from the first line rights hereinbefore granted.

It is understood that the person securing this grant has no authority to make any agreement not expressed herein in regard to the subject herein, and no agreement not expressed herein with respect to the subject herein shall be binding on the Grantee, its successors or assigns.



## RIGHT OF WAY AGREEMENT APPROVED
